collect or store your payment card details, and we do not sell any physical goods.

Billing and renewal. The price, currency, and billing period are shown in the App Distributor's purchase screen before you confirm. Your subscription renews automatically at the end of each billing period, and the App Distributor charges the payment method on file with your Apple ID or Google account, unless you cancel at least 24 hours before the end of the current period.

Free trial. Where the App Distributor offers a free trial, the trial length is shown at purchase. When the trial ends your subscription converts to a paid subscription unless you cancel before the trial ends. Free trials are limited to one per user.
